



## Dos and Don'ts on the factory premises



Machines, tools, equipment, conveyor technology and materials must not be touched without permission.



Fire and naked flames are prohibited!



No photography or filming, smartphones included!



Smoking not allowed in any building. Smoking permitted only in designated areas.



Alcoholic beverages and other intoxicating substances may not be brought into the factory or consumed there.



Persons with pacemakers must not enter areas marked with this sign!



Maximum speed on company premises!



Do not enter the production areas without permission.

## What to do in case of fire

### Keep calm

#### Report the fire



Fire brigade emergency number 112



or activate the fire alarm

#### Get to safety



• Follow marked escape routes

• Warn people in danger

• Take people needing assistance with you

• Close windows and doors



• Go to assembly point

• Do not use the lift

• Follow instructions

#### Attempt to extinguish the fire



Use fire extinguisher

## Dear Visitor,
